May 29	Friday	Last day for degree plan to be received by the Office of Graduate and Professional Studies if graduating in December 2020.
July 29	Wednesday	Electronic Thesis/Dissertation System Re-Opens for December 2020 degree candidates.
August 12	Wednesday	First day to apply for degrees to be awarded in December 2020.
August 12	Wednesday	First day students are able to clear dissertation for Fall graduation.
August 18	Tuesday	Last day to register for Fall semester classes. Refer to Student Business Services for tuition and fee dates.
August 19	Wednesday	First day of Fall semester classes.
August 21	Friday	Last day to CLEAR for Summer 2020 graduation. (Applies ONLY to those students not clearing final audit on degree audit night.)
August 25	Tuesday	Last day to clear thesis by 5:00 p.m. to avoid registration in Fall 2020 semester.
August 25	Tuesday	Last day for adding/dropping courses for the Fall semester by 5:00 p.m.
September 18	Friday	LAST DAY TO APPLY FOR DEGREES TO BE AWARDED IN DECEMBER BY 5:00PM without a late fee. A diploma fee of \$47.50 must be paid either at registration or at Student Business Services (GSC). Complete the application for degree form via the Howdy Portal. A LATE CHARGE OF \$50.00 WILL BE ASSESSED TO STUDENTS WHO APPLY FOR GRADUATION AFTER 09-25-20.
October 2	Friday	Last day to submit "Request and Announcement of the Final Examination" or 10 working days prior to the examination, whichever comes first to the Office of Graduate and Professional Studies.
October 16	Friday	Last day to take final exam. (defend dissertation or record of study)
October 23	Friday	Last day to submit a signed approval form and PDF of the dissertation in final form by 5:00 p.m. Signed approval form is submitted to OGAPS. The PDF file must be submitted via the web to http://thesis.tamu.edu .
November 10	Tuesday	Last day for <u>all</u> students to drop courses with no penalty (Q-drop). Last day to officially withdraw from the University.
November 24	Tuesday	Last day to apply for graduation

ADDITIONAL DEADLINES FOR DEGREES TO BE CONFERRED IN DECEMBER 2020

October 30	Friday	Last day to submit petitions to change degree plan coursework for students in master's programs without a final examination requirement: MAB, MBA, MCS, MED, MEN, MET, MHA, MIA, MID, MIP, MJ, ML, MML, MMR, MOS, MPH, MPSA, MRE, MSN, MGS Non-Thesis Distance programs in Geosciences, MS programs in Mays Business School, MS programs in EHRD – HRD option, MS Non-Thesis programs in Engineering, MS in Energy, MS in EDPH, and MS in ECON.
January 15, 2021	Friday	Last day to CLEAR for Fall 2020 graduation. (Applies ONLY to those students not clearing final audit on degree audit night.)
