- 1. *Curricular Items Due*: deadline for curricular items (course and program proposals) to be received from college/school approver, through CARS, to the Graduate and Professional Council Preparer box for review
- 2. **Changes to Curricular Items Due**: first deadline for updates to discussion items and department responses to reviewer comments with revisions to course and program curricular items; curricular items with comments resolved will be placed on the Consent Agenda; all unresolved courses and programs will be placed on the Curricular Agenda
- 3. *Release of Final Agenda*: final agenda sent to Graduate and Professional Council members; will include discussion items, Consent Agenda with curricular items ready for approval, and remaining Curricular Items for further review and discussion
- 4. *Graduate and Professional Council Meeting*: monthly meeting (first or second Thursdays dependent on Faculty Senate's adjusted deadlines and university holidays/breaks) of the Graduate and Professional Council to review discussion and curricular items
- 5. *Final Changes Due*: second deadline for department responses to GPC comments and revision of course and program curricular items in preparation of report to Faculty Senate; course and program curricular items approved by the Administrative Assistant and forwarded to Faculty Senate Preparer box in CARS; copy of agenda with approvals, meeting minutes, and relevant attachments forwarded to Faculty Senate
- 6. Faculty Senate Meeting: monthly meeting (second Mondays except when adjusted for university holidays/breaks) of the Faculty Senate to review discussion and curricular proposals
