The Bush School Admissions Office is requesting an exception to the degree equivalency requirement for a Fulbright recipient: Ms. Nesa Marku. To justify this request we are providing a brief background, a justification the exception, and a future path forward.

#### Background:

Nesa Marku, from Macedonia, started pursuing a Bachelor's in International Relations at Blanquerna Ramon Lull in Barcelona in Sept 2018 before transferring to the University American College in Skopje in February 2019. She graduated in May 2022, with a 3.24 GPA with a BA in International Relations and Diplomacy. Her diploma supplement states the program duration as 3 (three) years, which was missed when the Bush School Admissions Office processed her application. As a result, Ms. Marku's entire applicant file (including academic performance, experience, personal statement, international experience essay, resume) were sent to the International Affairs Admissions Committee to evaluate. They decided she was a promising candidate and invited her to interview with two members of our faculty. Ms. Marku did exceptionally well in our interviews, impressing faculty with her international experience and focus on intelligence studies. On March 9, she was offered admission to the Bush School's Master of International Affairs and the decision was sent to Texas A&M Admissions to process. We mistakenly thought her degree would be evaluated for equivalency at this point and critically, that this evaluation would take place prior to an admission offer being sent to her. This did not occur and her admission record was activated on March 10th; she accepted the offer one month later.

The Fulbright office then notified the other universities that that she declined their admissions offers and began the immigration paperwork to ensure she could enroll with us by mid-August.

To our dismay, on April 17, we were notified by Texas A&M Admissions that Nesa Marku's degree is a 3-year degree that does not meet TAMU standards for a bachelor's degree and we cannot admit her. The Institute for International Education (who administers Fulbright Awards) directed us to request an exception in order to move Ms. Marku forward in their process and allow her to enroll at Texas A&M for the Fall 2023 semester. Fulbright's admission process (described below) means that IIE has already declined her admission offers at other universities; essentially, we will leave Ms. Marku stranded and burn bridges with IEE if we do not obtain this exception.

# Factors which led us to admit Nesa Marku and which we believe qualify her for an exception to the degree equivalency requirement.

- Nesa Marku was selected through a competitive process to receive a Fulbright award to study in the United States. This places her in the category of high achieving students who we want to attract to our program and who possess the academic qualifications to succeed in our program.
- We perform a complete and thorough holistic review of applicants with additional steps to ensure that we can evaluate international applicants equally. (See the appendix describing our admission steps for international students.) This process revealed her to be highly qualified.
- The courses which Nesa Marku has completed (her full transcript is attached) are broadly consistent with the core curriculum which would be required for an undergraduate major in International Studies (the BA degree we offer) with a few exceptions, none of which give us pause about her preparation for this degree:
  - She has not taken Life & Physical Sciences
  - O She has not taken 6 credits of U.S. History, although she has taken other history classes.
- She has completed coursework that would be broadly comparable to coursework in the major for a student graduating with our undergraduate degree.

This combination of factors, combined with her superb performance on the interview with faculty, gives us confidence that Ms. Marku has the background and preparation necessary to be successful in the Master of International Affairs program.

# A Recurrent Problem, especially with Fulbright, for which we are seeking long-term solutions The Bush School's Admissions Department works each year with the Institute of International Education (IIE) in processing Fulbright applications to both our Master of Public Service and Administration and Master of International Affairs. IIE applies on the applicants' behalf, serving as the primary contact. Our Bush School faculty and staff review their application, evaluate their supporting

materials, and conduct interviews with the most promising. As it stands right now:

• IIE Fulbright evaluates all offers for the applicant and places applicants in colleges/programs across the US. We are not allowed to communicate with the applicant directly. IIE Fulbright Office evaluates all offers an applicant receives and places the applicant in a specific university. The applicant rarely decides where he/she will attend.

- When students have been placed, IIE Fulbright:
  - o emails Bush School Admissions letting us know which applicants have been placed in our program/college,
  - o emails the applicants to let them know which college/program they've been placed in,
    - For applicants placed in the Bush School, IIE Fulbright also forwards them the email above from TAMU Admissions (with the UIN) and instructs them to create a NetID/Login to accept their offer in Howdy.
  - o notifies the other universities of the decision (declining others when accepting ours),
  - o and starts the immigration paperwork process for the applicant.
- If the applicant accepts the Fulbright and admission offer, it takes another few business days for the applicant's status to update to that of an admitted student. Once the applicant's status is updated to admitted, the Texas A&M Admissions Office sends an admission letter to the applicant's physical address. Only then can the applicant (now student) proceed with registration, etc.

This process worked until TAMU Admissions changed their process in Fall 2021 to require applicants to accept their offer of admission before reviewing their transcripts.

After this incident, we asked Texas A&M Admission to immediately review for degree equivalencies the other 14 IIE Fulbright applications we received this cycle. We were told two others had 3-year equivalencies for their bachelor's degrees and two more needed further research. Of those, three were offered admission in March, but IIE had not provided a decision yet. We have since rescinded those offers based on the degree evaluations. The other applicant was still under review, but will now be denied admission.

We cannot have IIE Fulbright doubt our intentions, or they will no longer place promising candidates with our programs. IIE pushed us to identify: WHEN do they know when an applicant is cleared for admission making it safe for them to place an applicant in our program and decline the rest? As an immediate solution for Fulbright applicants, the Texas A&M Admissions Office has agreed to evaluate transcript(s) to ensure applicants' degrees are US 4-year degree equivalent before we consider them for admission. This will avoid the embarrassing step where we have to rescind an admission offer.

We are working with the Office of Admissions to determine a clear process for non-Fulbright applicants to ensure a quick and timely review of applications and to ensure this happens after we make a decision, but before we notify the applicant of admission. We will verify that process works prior to issuing decisions during the Fall 2024 admission cycle.

Unfortunately, the certificate is coded as major-dependent (OBIO) so only students pursuing the OBIO program can receive this certificate. I am not aware of a waiver. The only way to allow them to pursue the certificate is to change the certificate to a standalone certificate.

Good morning!

Get a big cup of strong coffee ...

We offer one MS, so if we require the GRE for the MS, it has to be for all MS applicants. So ... after talking with Admissions when this standardized testing became a hot topic, we deleted the requirement for the MS and if any Certificate program required it .. whether attached to an MS as a secondary curriculum or not ... they could require it as a part of the Certificate application process. All of our clinical programs use an application program called ADEA PASS (American Dental Educator's Association Postdoctoral Application Support Service).

Orthodontics and Oral Surgery were forwarded an email similar to the one I responded to and told if they required a standardized test they had to get it approved. It went out before I could stop it.

We have a "basic science track" MS in Oral Biology and a "basic science track" PhD in Oral and Craniofacial Biomedical Sciences. They apply directly to the University. This MS is the same one the clinical students pursue. They just have radically different degree plans.

Then our clinical programs break out this way ...

#### Certificate only groups that due to their short nature have never added the optional MS:

AEGD (Advanced Education in General Dentistry) – 12 months.

Dental Public Health – 12 months

# Certificate only groups that have students occasionally add an MS (apply separately to get approval for direct admission):

Endodontics -27 months (have seen a great interest in the past few weeks ... six of the eight currently enrolled students have added the MS)

Oral & Maxillofacial Radiology – 24 months (one pursuing an optional MS now ... a second approached me yesterday, but has to figure out money and visa issues before she can decide for sure)

Oral & Maxillofacial Surgery #1-48 months (demanding nature of this program would not allow the addition of an optional MS)

Oral & Maxillofacial Surgery #2 – 48 months (but adds another 24 months at Texas

Tech to add an MD before they are here physically)

Pediatric Dentistry – 24 months (Irish students routinely add the MS as Ireland requires their training to be at least 36 months in length)

#### **Certificate and Mandatory MS groups:**

Oral & Maxillofacial Pathology – 36 months (Certificate can be awarded *before* their MS due to the way their Boards are set up)

Orthodontics – 36 months (the MS must be awarded before or simultaneously with the Certificate)

Periodontics – 36 months (the MS must be awarded before or simultaneously with the Certificate)

Prosthodontics – 36 months (the MS must be awarded before or simultaneously with the Certificate)

As usual, we are all over the map, and standardized tests are used in various ways, based on many things, including the competitive nature the applicant pool.

Soooo ... all that being said ... am I correct in that any variances from the "we do not require a standardized test for our MS applicants" need to be addressed when the applicant completes the Certificate application? And if so, they would <u>not</u> need to submit anything to the Graduate School for approval.

Dear Grad Community,

You may recall that with approval by the President and the Board of Regents in the Spring of 2022, the university decided to permanently eliminate the university standardized test requirement for graduate admissions starting from the recruiting cycle of AY2022-2023 (Fall 2023, Spring 2024, and Summer 2024 admissions) and beyond. Individual programs have been allowed to require official scores on a standardized test on a conditional basis for the recruiting cycle of AY2022-2023 (Fall 2023, Spring 2024, and Summer 2024 admissions) upon request with a justification and approval by the Texas A&M University Graduate and Professional Council (GPC).

Programs that currently have an exception approved for the recruiting cycle of AY2022-2023 (Fall 2023, Spring 2024, and Summer 2024 admissions) and want to continue requiring standardized testing scores for the recruiting cycle of AY2023-2024 (Fall 2024, Spring 2025, and Summer 2025 admissions) and beyond will need to submit a new request via memo through their GOC Dean to the Associate Provost and Dean of the Graduate and Professional School and Chair of the Graduate and Professional Council (GPC) requesting an exception. The request must include a justification of why standardized test scores are needed and how they will be used in the admissions decision process. Guidance approved by the GPC has been attached to this email which should help programs understand what the GPC is looking for. Requests for exception can be sent to gpcadmin@tamu.edu.

All memos must be received by the Associate Provost and Dean of the Graduate School no later than close of business on April 14, 2023. As a note: programs which do not currently have an approved exception but wish to require standardized test scores may also submit a memo for consideration. In order for the memo to be approved to require test scores for Fall 2024 admission and beyond, the memo must be received by close of business April 14, 2023.

The Nautical Archaeology Program of the Department of Anthropology currently offers an oncampus Master of Science (M.S.) degree in Maritime Archaeology and Conservation (MARC). This is the only terminal Master's degree program in the Department. The eight faculty of the Nautical Archaeology Program request that GRE scores continue to be a requirement for individuals applying to:

M.S. / Maritime Archaeology and Conservation (MARC) / on-campus / thesis option

#### **Program Summary**

Since its inception in 1976, the Nautical Archaeology Program has been exclusively a graduate program. From 1976 until 2014, graduates earned an M.A. in Anthropology with an emphasis in Nautical Archaeology. Beginning in 2015, graduates earned an M.S. in Maritime Archaeology and Conservation. The redesigned degree program maintains faculty expertise in (a) the history of shipbuilding and seafaring around the world and throughout time, as well as (b) the fundamentals of archaeological artifact conservation, while (c) providing specialized training in the application of technologies (i.e. remote sensing) that are a requirement of various professional employment opportunities that did not exist when the program was established 47 years ago.

The M.S. is designed to prepare students for employment in maritime museums, cultural resource management (CRM) firms, and federal, state, or similar government agencies. Graduates who pursue a career in archaeology outside of academia often seek credentials with the Register of Professional Archaeologists (RPA). The designation of Registered Professional Archaeologist requires an advanced degree and evidence of substantial data analysis as contained in a thesis or dissertation. Since 1976, M.A. and M.S. graduates of the Nautical Archaeology Program have been required to write a thesis as part of their degree requirements.

Anthropology 4352 TAMU College Station, TX 77842 The Nautical Archaeology Program is the oldest graduate maritime archaeology program in the world. In the U.S., there are other programs at East Carolina University and the University of West Florida. Outside of the U.S., there are maritime archaeology graduate programs at Flinders University (Australia), the University of Southampton (England), Université Aix-Marseilles III (France), and the University of Haifa (Israel).

Applicants to the Nautical Archaeology Program are diverse, both academically and geographically. It is virtually impossible to prepare at the undergraduate level for an advanced degree in Maritime Archaeology and Conservation, in the way that a graduate student in English or History or Anthropology is likely to have been an undergraduate major in English or History or Anthropology. Applicants to our program come from a wide array of educational emphases including Anthropology, Archaeology, Classics, History, Chemistry, Engineering, and Psychology. The student body of the Nautical Archaeology Program is also globally diverse, with graduates from Belgium, Brazil, Bulgaria, Canada, Colombia, Denmark, Finland, Greece, Israel, Italy, Japan, Mexico, the Netherlands, Peru, Poland, Portugal, South Africa, Spain, Switzerland, Taiwan, Turkey, and the United Kingdom.

## **Justification**

Forty-five years of collective experience reading graduate applications to the Nautical Archaeology Program suggests that GRE scores are a very useful tool for comparing applicants from an array of universities, colleges, and programs, both domestic and international. Of course, GRE scores are not the only factor considered in our review but they are an extremely helpful complement to other application materials. GRE verbal and writing scores, for example, provide a consistent standard to assess writing fluency, which we know to be of critical importance for the preparation of a thesis which is a requirement of the M.S. in Maritime Archaeology and Conservation. GRE quantitative scores are often a helpful indication of how a student is likely to fare in our Ship Reconstruction course (ANTH 616) in which students learn how to calculate a ship's volume, dimensions, and various coefficients, or in our Conservation of Archaeological Resources course (ANTH 605), which deals with chemical formulas and equations. Both of these courses are among the five required of all students seeking the M.S. in Maritime Archaeology and Conservation.

#### **Process for the Use of Scores**

All eight faculty of the Nautical Archaeology Program read, review, rank, and discuss the merits of each applicant's curriculum vitae, personal statement, school ranking and program quality, overall grade point average and relevant coursework, quality of recommendation letters, and writing sample. GRE scores will not be weighted higher than any other application component, nor will they be used exclusively to determine an applicant's merit. According to our evaluation rubric, the GRE scores account for 10 out of 100 total points that an applicant can receive. Since the inception of the Nautical Archaeology Program, GRE scores have served as one of several tools we use to evaluate applicants and we are asking for the continued use of this dataset to help us distinguish the best candidates for our program.
